he implementation of the and European Development Fund (EDF) Programmes has been instrumental to the delivery of Nigeria's reform in-

ment Blueprints over the 20 - year period from year 2000 -2020 of the Cotonou Partnership Agreement between the Africa, Caribbean and Pacific States and the European Union. As a key instrument of the Cotonou Partnership Agreement for poverty reduction in the ACP, the EDF opened-up a wide spectrum of areas and

opportunities in deepening the Nigeria - EU Development Cooperation since the return to democratic rule in 1999. The commitment of a total sum of €1.781m EDF grant aid to support the achievement of the mutual objectives of the partnership in strengthening governance or institutions or provision of catalytic infrastructure have demonstrated

possibilities for change while contributing to economic growth, sustainable development and welfare of the citizenry.



Introduction

Context of the EU – Nigeria Development Cooperation from 2000 — 2020

s part of its core responsibility for formulation and coordination of medium and long term ecodevelopment plans as well as coordinate of such plans at the Federal and Sub-national levels, the National Planning Commission Act 71 of 1993 empowers the Federal Ministry of Budget and Economic Planning with the mandate for management of Multilateral and Bilateral economic cooperation, including official development and technical assistance on behalf of the Government of Nigeria. In this regard, the Ministry fosters cooperation with international development partners in covering the capacity and national budgetary gaps for achievement of Nigeria's economic growth targets and poverty reduction goals.

With the return to democratic rule in 1999 and the new orientation for minimal involvement of government in driving the economy, development cooperation resources in form

of grant aid and technical assistance were strategically factored in Nigeria's Poverty Reduction Strategies and Medium Term Development Plans for achievement of the national development aspirations. This entailed engagement with the development partners for commitment and utilization of financial or technical grants within the parameters of the national or sectoral policies and plans, global development objectives and mutual cooperation agreement entered with partners. On the backdrop of a long history of military rule with the

attendant political instability, weak democratic institutions and inefficient economic systems, the initiatives for development partners' assistance in the country were directed at

- a) Support to improvement of service delivery in public health services, water supply and sanitation, and education;
- b) Strengthening the rule of law and governance; and
- c) Support to economic cooperation and energy.

On the restoration of diplomatic ties with most advanced countries after the Nigerian General Election in 1999, the development cooperation between the Federal Republic of Nigeria and

the European Union took-off in earnest on July 16, 2002 when the Chief Economic Adviser to the President/ Vice-Chairman of the then National Planning Commission, Dr. Magnus Kpakol and the European Union Commissioner for Development and Humanitarian Aid, Poul Nielson signed the Country Support Strategy and the National Indicative Programme of the 9th European Development Fund (EDF) in Abuja on July 16, 2002. This consolidated an earlier Quick Start Package of Interventions for 1999 - 2000 for the country by the EU Commission.

In line with the framework of the 20 years Cotonou Partnership Agreement between the EU and Organisation of Africa, Caribbean and Pacific States (OACPS) signed in

the year 2000, the Federal Ministry of Budget and Economic Planning followed-up with the EU in programming the financial resources for Nigeria and coordination of stakeholders for delivery of the EDF projects, as required. The task entailed an elaborate structure of engagement with stakeholders including the EU Delegation in Nigeria, Federal and States Ministries, Department and Agencies, (MDAs), EU Member States Development Agencies and other International Development Partners, Civil Society Organisations (CSOs) and community leaders in harmonization of views and approach for achievement of the objectives for the EU -Nigeria Development Cooperation in the various spheres of intervention.

1.2 Relevance of the Photobook

In consonance with the 2011 Busan Partnership Agreement for Promotion of Effective Development Cooperation to promote ownership of development priorities, focus on results, joint risk management, inclusive partnership, transparency and accountability of initiatives, this Photobook will provide basic facts in Nigeria's development cooperation with the EU in the framework of the

Cotonou Agreement and, particularly, showcase the milestones achieved with a view to raising public awareness on their responsibilities for sustainability of the intervention projects executed from 2000 - 2020.

Scope

- 15. This Photobook/Documentary focus on:
- i. Showcasing key infrastructure deployed across the

thematic areas of health, water & sanitation, energy, and resilience in a cross section of States in the North, South West, South-South and South Eastern parts of the country; and

ii. Point out the responsibilities of beneficiaries – Government and host communities in maintaining the facilities deployed for sustainability and appreciation of the goodwill of the EU taxpayers.

A Brief on the European Development Fund in Nigeria

democratic governance Nigeria in 1999 opened up opportunities following the suspension of multilateral and bilateral relations with the military regime on many fronts. On 15th May 2001, the European Council of Ministers adopted a Common Position for strengthening mutually beneficial relations between the EU and Nigeria in all policies within the political, economic, trade and development fields through a consistent and coherent approach guided by the Nigeria's priorities. In this vein, Nigeria enjoyed technical and financial cooperation resources from the European Development Fund (EDF), the main instrument of cooperation in the 20-Years

he return to

Partnership Agreement signed between the Africa, Caribbean and Pacific States and the EU in Cotonou, Benin Republic in Year 2000.

2. As a unique aid modality anchored on a formal legal-contractual framework, with provisions for predictable resources, the EDF was deployed as grants or non-reimbursable aid in line EU's commitments for achievement of Universal Goals, i.e the Millenium and Sustainable Development Goals in the 79 ACP countries. The ACP and EU Commission jointly determined the EDF after the EU member States contribute to an envelope on a five to six-year basis. Indeed, the financial resources of the EDF were sourced from the public treasury of each Member State.

3. In commitment of the resources, specific funding enve-

lopes are allocated to:

National Indicative Programmes (NIP) for each of the 78 ACP member States;

Regional Indicative Programmes (RIP) for each of the ACP Regional blocs such as ECOWAS, towards regional development and integration; and

The Intra-ACP Facility through the ACP Secretariat for addressing broad and common development themes.

4. Covering the period 2000 – 2007, the global financial assistance under the 9th EDF amounted €13. 5 billion in grants. Total resources made available under the 10th EDF to cover the six-year period from 2008 – 2013 was €22.682 billion. In the final phase of Cotonou Agreement, the EU Commission committed €31.5 billion

for the 11th EDF (2014–2020) funding cycle. Nigeria accessed €552 million, €677 million and €562 million under the 9th EDF (2000 – 2007), 10th EDF (2008 – 2013) and 11th EDF (2014 – 2020) National Indicative Programmes (NIPs), respectively.

5. It is however pertinent to note that the EU Development Cooperation Policy and modalities results from a combination of complex internal legislative, budgetary and procurement procedures, as well as international agreements. On this basis, the EU Delegation in member States, serve as the representative of the EU Commission/Financing Authority, while a Government Agency (mainly Ministries in charge Economic/Development Planning) serve as the Focal Agency/National Authourising Office for commitment of the funding envelopes of the National Indicative Programme for the country.

6. In the case of Nigeria, the EU Delegation in Abuja is the Financing Authority for both the Nigerian National Indicative Programme (NIP) and the West - Africa/ECOWAS Regional Indicative Programme (RIP). Conversely, the Federal Ministry of Budget and Economic Planning (as currently constituted) is the National Authorising Office of the EDF – National Indicative Programme (NIP) for Nigeria while the ECOWAS Secretariat is the Regional Authorising Office (RAO) for the West African Regional Indicative Programme (RIP).

Priorities for Sectoral Interventions of the EDF

7. In line with the objective of the ACP – EU Cotonou Partnership Agreement to foster sus-

tainable socio-economic development and to sustain the campaign against poverty in the ACP member States, commitment of the EDF resources in Nigeria were directed at poverty reduction and improvement in the social welfare indices as conceived in the National Development Blueprints. Hence, the various EDF - National Indicative Programmes (NIPs) focused at supporting the Government of Nigeria's efforts for improved service delivery and better quality of life through quality and accessible basic primary health care and immunization systems, potable water and sanitation facilities and energy especially in the rural and semi-urban areas. For a comprehensive approach, the Nigerian EDF Programmes included non-focal sector projects on strengthening democracy, governance and macroeconomic stability among others, as part of initiatives to facilitate effective utilization of

public revenues for delivery of social services,

8. Thus, the financial enve-

lopes of the EDF – National Indicative Programme for Nigeria were allocated for thematic interventions as follows:

9. The commitment of the Funds was done through projects implemented by special-

ised International Development Partners, EU – Member States Agencies or other commissioned Agents. The EU Delegation and the Federal Ministry of Finance and Economic Planning provide oversight; ensuring effective coordination of stakeholders, facilitation of initiatives and tracking or confirming progress based on specified indicators.

10. With respect to the strategic initiatives of the EDF for poverty alleviation in Nigeria:

55.1% of the resources were directed at improving service delivery mechanisms, through support to good governance, institutional strengthening and reform of public finance management; and 44.9% at provision of infrastructure to demonstrate possibilities for change and galavanise action to impact a larger proportion of the population

The EDF interventions in the water and sanitation sector were focused on:

- Improving the Water Policy and Institutional Framework at Federal level and focal/beneficiary States
- Supporting urban and small towns water institutions in the focal/beneficiary States to deliver sustainable water supply and sanitation services; and
- Strengthening rural water supply and sanitation institutions in the EU focal/beneficiary states to deliver sustainable water supply, sanitation and hygiene services.

The water and sanitation sector initiatives in the 9th and 10th EDFs were implemented under the:

- EU Support to Small Towns Water Supply Programme (STWSP);
 - Niger Delta Support Programme (NDSP) III; and
- Water Supply and Sanitation Sector Reform Programmes I, II & III.

Various schemes were implemented to boost access to drinking water were implemented in 14 Focal/beneficiary States, namely:

Kano, Jigawa, Yobe, Anambra, Cross-Rivers, Ondo, Ekiti, Osun, Plateau, Adamawa, Edo, Bayelsa, Rivers and Akwa Ibom.

The beneficiary State Governments contributed up to 30% of funds needed to ensure its effective implementation while the EU made available the remaining 70%"


WSSSRP III Implemented in Adamawa, Ekiti and Plateau States:

- Supported completion of Sanitation Strategy for Small and Urban towns completed;
- Built capacity and strengthened various institutions at the State and Local Government levels to enable them fulfil their mandate of delivering sustainable water and sanitation;
- Supplied of laboratory equipment, generators/inverters, office/ICT equipment and vehicles;
- Facilitated passage/gazetting of the Plateau State Water Law has been signed into law and the process of gazetting the law is in progress;



110 new boreholes constructed, 106 water schemes rehabilitated, and 277 new **VIP** latrine projects delivered in the WSSSRPII Focal States, namely: Anambra, Cross River, Jigawa, Kano, Osun and Yobe.





WSSSRP II implemented in Anambra, Cross River, Jigawa, Kano, Osun and Yobe States, as well as, the Federal Ministry of Water Resources:

- Supported enactment of Water Laws in Osun, Kano and Anambra States;
- Successfully constructed & handed over Water Supply and Sanitation Schemes to the beneficiary communities;
- Supplied Office and Hydrological Equipment to the six States Ministry of Water Resources;
- Facilitated the adoption and replication of Community Management strategies (WASHCOMS & WCAs) adopted for the operation and maintenance of water and sanitation facilities;
- Supported the promotion of Integrated Water Resources Management (IWRM) principles, flood risk management planning and forecast including GIS training for water assets

Through the 1^{1th} EDF Resilience in Borno Programme:

- 11 boreholes rehabilitated and 5 new drilled in Monguno. 1 rehabilitated and 2 drilled in Nganzai, 7 boreholes rehabilitated in Damboa, 2 drilled in Kaga Local Government Areas;
- 33,600 (13,440M, 20,160F) individuals reached with safe drinking water construction and rehabilitation of boreholes in 4 Local Government Areas:
- 2,648 latrines constructed in 3 LGAs through sanitation marketing vendors; and
- 2 Schools in Monguno, 1 school in Nganzai and 11 schools in Damboa equipped with gender mainstreamed WASH facilities.

Through the 11th EDF Support to the North-East (Borno) implemented by GIZ:






















NDSP 3 Implemented in Akwa Ibom, Bayelsa, Rivers, Edo and Delta states:

- Over 1.1 million people gained access to basic WASH services across the beneficiary States.
- Beneficiary communities in Akwa Ibom, Bayelsa, Rivers, Edo & Delta States attained Open Defecation Free (ODF) status including capacity to operate, maintain and repair their water supply facilities.
- The Local Government Water and Sanitation Health (WASH) Departments/Units equipped with both skills and tools to support communities in implementing village level operation and maintenance of their water-related systems.
- A total of 493 schools received WASH in schools' intervention providing school pupils with access to safe water sources and sanitation facilities.
- The capacity of government officials in the various states was also built to utilise data, analyse, plan, budget and implement programmes for provision of WASH services.

The EDF interventions in the Health sector were focused on:

- Improving States and Local Government Areas' management systems and stewardship of Primary Health Care (PHC) geared towards routine immunisation including policies and practices/guidelines for PHC;
- Supporting the delivery of Routine Immunization (RI) services via the PHC system including provision of infrastructure for RI, transport, and immunisation equipment;
- Improving information and knowledge generation for RI including operational research to drive policies, planning and RI programme implementation;
 - Support efforts aimed at eradication and maintaining a Polio-free Nigeria;
- Strengthening capacity for effective coordination of Maternal and Newborn Child Health (MNCH) service delivery and social protection;
 - Improve the quality of health and nutrition information system including its use for decision making;
- Strengthen local institutional capacity at state level to plan, prepare costed budgets, provide full narrative and financial reporting for the health sector; and
- Improve availability, access and utilisation of quality basic health services in areas of refuge, return or resettlement in Borno State.

The Health sector initiatives in the 9th, 10th and 11th EDFs were implemented through the:

- Partnership to Reinforce Immunisation Efficiency (PRIME) Project;
 - Support to Routine Immunisation in Kano (SRIK) Project;
- Support to Immunisation Governance in Nigeria (SIGN) Programme;
 - Support to Scale-up MNCH in Northern Nigeria;
 - Support to the Health Systems Strengthening Phase I; and
- Support to Restoring and Strengthening Health Services in Borno State Programme.

Various approaches were adopted for implementation of the Health sector initiatives in 25 Focal/beneficiary States namely:

Guided by the provisions and instruments of the OACPS - EU Cotonou Partnership Agreement which subsisted from the year 2000 - 2020, the 9th, 10th and 11th EDF Programmes have significantly contributed to the stock of infrastructure as well as strengthening the governance systems for addressing some of the challenges militating against economic growth and sustainable development in Nigeria. Over the past 2 decades, Nigeria's development cooperation

with the EU is notably one of the most vibrant development partnerships in terms of volume, thematic interventions. modalities and geographical spread in deployment of resources.

From an average annual economic growth rate of 7% experienced in 2000 to 2014, which fell to 2.7% in 2015 before the 2 recessions in 2016 and 2019, there is need for robust economic growth beyond the current average annual rate of 3.2% to support productivity for jobs creation and social inclusion in Nigeria. The current state of the Nigerian economy like in most African countries in the Post-Covid 19 era, require broad-based dialogue and partnerships to make a difference in through innovative solutions that will stem the fast-growing rate of poverty in the country. In this vein, initiatives at addressing the structural imbalances in the economy, while taking measures to both reduce the likelihood of future shocks and improve the nation's resilience are paramount.

For an emerging economy with a youthful population, harnessing the demographic potentials for increased economic growth and better quality of life through education, employment and productivity in the country cannot be overemphasized. In conceiving and implementing policies for moving labor and economic resources

from low to high productivity sectors, Nigeria requires technical assistance and innovative financing mechanisms in support of climate smart ventures and agriculture, investments in social infrastructure, digitalisation and ensuring fiscal sustainability, among others.

In line with the Mandate for coordination of multilateral and bilateral economic cooperation, including development aid and technical assistance programmes in the country, the Federal Ministry of Budget and Economic Planning will leave no stone unturned in leveraging on Nigeria's long standing development cooperation with the EU for partnerships in implementation of initiatives for sustainable economic development in the country. In this vein, the 7th Nigeria - EU Ministerial Dialogue held on 18th November, 2020 agreed to reinvigorate a strategic and mature political partnership that

would be comprehensive, balanced and mutually beneficial for the Parties. The EU-Nigeria Strategic Dialogue held in Abuia on 19th October, 2023 further showcased the EU-Global Gateway Package among other instruments of cooperation in support of efforts towards an enhanced transformative economy in Nigeria.

Building on our long-standing cooperation and in the best spirit of shared responsibility. commitment, and accountability, it is envisaged that constructive dialogue of stakeholders would inform decisions and joint actions in implementation of initiatives for the mutual benefit of the EU - Nigeria Development Cooperation as the new OACPS-EU Samoa Partnership Agreement comes into force.

he documentation of about 5,200 projects covering the health, water and sanitation, energy and education sector EDF intervention projects across 4980 communities through this Photobook is a watershed in the annals of the EU - Nigeria Development Cooperation.
